ORDER

Ms. Jana Kumari, DoB 07.08.1995, was appointed as Junior Engineer-I (Mechanical), PT vide order no. RVUN/P&A/F.DR(97)ME/D. 193 dated 16.08.2017 and joined duty on 04.09.2017. After joining, Ms. Jana Kumari remained willful absent from duties from 05.09.2017 to 15.01.2018 (133 days), 17.01.2018 to 28.05.2018 (132 days) and from 30.12.2018 to 07.01.2019 (09 days) for which disciplinary action was initiated against her. As per decision of Disciplinary Authority i.e. Chairman & Managing Director issued vide order no. RVUN/P&A/Estt./F.30(239)/D. 936 dated 13.07.2022, her absence period from 05.09.2017 to 15.01.2018 (133 days), 17.01.2018 to 28.05.2018 (132 days) and from 30.12.2018 to 07.01.2019 (09 days) has been declared as "dies-non" and is not countable for any purpose i.e. she is required to complete the probation training period afresh. Accordingly, her probation training period has started afresh from 08.01.2019.

On completion of two years of satisfactory service from 08.01.2019, the probation training period of Ms. Jana Kumari, Junior Engineer-I (Mechanical), is hereby cleared and allowed the minimum (first cell) of Level-10 in the pay matrix i.e. Rs. 33,800/- as a basic pay from the day following the day on which she has completed two years of Probation Training period.

The period of 'Probation Training' shall not be counted for grant of Annual Grade Increments and other financial benefits.
